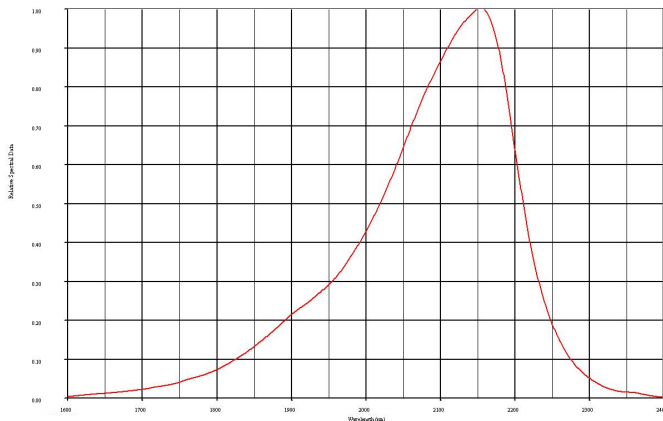

SPECTRAL RESPONSE



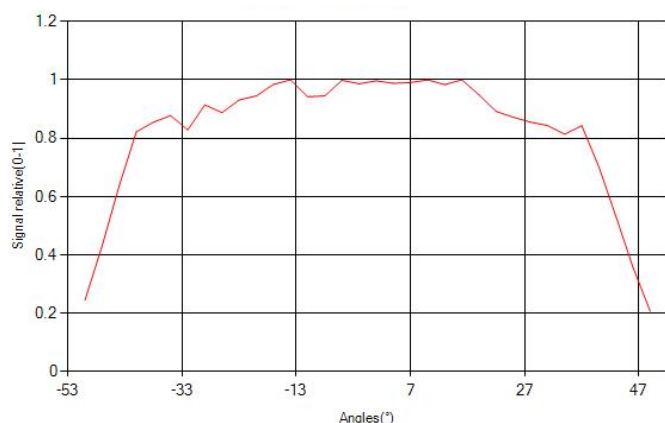
